Post-Election Impact on the Arts

The midterm election means many expected and unexpected results on the federal level, with many new member-elects joining Congress as well as changes in congressional leadership. In Congress, a new Republican majority in the U.S. Senate means that all of the Senate's committees and subcommittees will see new chairmen. The U.S. House also increased its current Republican majority. For the first time in eight years, the Republican Party will control both houses of Congress when the new Congress takes office in January. The Congressional Arts Caucus Co-Chairs **Rep. Leonard Lance** (R-NJ) and **Rep. Louise Slaughter** (D-NY) have been re-elected, but in a surprise sleeper race, Rep. Slaughter won her seat by only 582 votes. Among all members of the Congressional Arts Caucus, approximately 70 percent will return

to Congress. In this new freshman class, there are some pro-arts member-elects, including **Alma Adams** (D-NC), who takes the vacant seat of former Rep. Mel Watt. She is anticipated to find a committee seat on the Education and Workforce Committee and has already announced plans to continue with her collage art while in DC. Many of the Appropriations Subcommittees will also see new chairs due to retirements. The subcommittee that oversees funding for the U.S. Department of Education and the Arts in Education programs will have a new chair as Rep. Jack Kingston (R-GA) ran for another office and was defeated. **Rep. Ken Calvert** (R-CA) is expected to continue to chair the House Appropriations Interior Subcommittee that oversees funding for the National Endowment for the Arts, and will be joined by

Rep. Betty McCollum (D-MN) as expected Ranking Democratic Member, ensuring that steadfast friends of the arts remain in the leadership of that very important subcommittee.

Passage of Rhode Island's statewide ballot measure on Election Day will now more than double the Rhode Island State Council on the Arts' annual budget for grants to artists and nonprofit arts organizations.

Arts Ballots Win Big on Election Day

For the 2014 elections, there was one notable state ballot measure regarding arts and culture. In Rhode Island, citizens voted overwhelmingly—by 60.5 percent of the vote—to approve **Question 5**, which will now provide a \$35 million Creative and Cultural Economy Bond to support the Rhode Island State Council on the Arts and several other cultural institutions. At the local level, the voters in six out of six counties in Utah impressively passed sales tax ballot initiatives by 60-plus percentage margins to fund arts and recreational programs and facilities. In the Scottsdale Unified School District (SUSD) in Arizona, voters approved a Yes To Children ballot measure that would increase property tax to raise \$18.8 million per year to reduce

classroom sizes and restore arts and physical education classes back into elementary schools. In Palm Beach County, FL, voters approved renewing Palm Beach County School Board's expiring property tax in order to raise \$36 million in the first year alone and pay for more than 500 arts, music, and physical education programs and teachers in more than 120 schools. In Mecklenburg County, NC, residents unfortunately voted against a quarter cent sales tax increase to fund schools, public university, libraries, and the Arts and Science Council. Nationwide Initiative for Setting Arts Education Standards in Schools

To make nationwide changes, Americans for the Arts has banded together with other national arts education partners to form the National Coalition for Core Arts Standards (NCCAS). The goal of NCCAS is to lead the charge in introducing standards for arts education disciplines—dance, music, media arts, theater, and visual arts—across the country, which will guide curriculum and instruction to help prepare students for college, careers, and citizenship. On October 20, 2014 songwriter and activist Ben Folds joined with NCCAS members to host the public launch of the standards which kicked off Americans for the Arts' work on the adoption and adaptation of these standards in all 50 states and the District of Columbia.

The standards are intended to serve a broad constituency of individuals and organizations—students, teachers, administrators, parents, and the community at large—with a common platform to address improvements to arts education in their schools.

In achieving the mission of ensuring a quality arts education for all of America's students, Americans for the Arts will be working with local and state advocates in every single state to promote the adoption or adaptation of these new standards. Federal Funding Caught Up (Again) in Election Dynamics

As the new fiscal year approached on October 1, Congress passed a continuing resolution (CR) to keep the government open and give Congress extra time to try to pass the FY 2015 appropriations bills to fund the federal government during a

lame duck session. Work now surrounds a "cromnibus" proposal, under which the National Endowment for the Arts would continue to see current funding levels of \$146 million, through the end of the current fiscal year ending on September 30, 2015. Congress is considering this proposal right up until the current CR

expires on of December 11, 2014 and the 113th Congress finishes its last business before the next Congress takes seat in January. Check www.AmericansForTheArts.org/news-room/legislative-news for the latest funding decisions as the House and Senate negotiate final FY 2015 spending bills.
